



# What's New in LepideAuditor Suite 15.1

This document describes the new and enhanced features of LepideAuditor Suite 15.1





## Introduction

LepideAuditor Suite (LAS) is a powerful, centralized auditing platform to monitor and audit Active Directory, Group Policy, Exchange Server, SQL Server, and SharePoint. The features like live updates, real-time alerts, instant audit reports, and customization empower administrators to discover configuration changes, do root-cause analysis, restore settings, meet compliance requirements of PCI, GLBA, SOX etc. and maintain security across your organizations.

In the latest version (15.1), LAS comes with some new features and existing feature enhancements which let you get more values out of the application.

## New Additions

Given below is a list of new features and enhancements of existing features in the latest version (15.1) of the LepideAuditor Suite.

1. Look and Feel of the application has been improved. Now it's more aesthetical to work with software.
2. The process of adding components has been simplified and shortened. In the new Express mode, components can be added in just a few steps.
3. Now it is possible to do agentless auditing in which case you don't need to install agents on the servers that you want to audit, thus doing minimum interruption to servers' functioning. This option is not available for SharePoint and Non-owner auditing.
4. New reports have been included in the Health Monitoring reports section for Active Directory and Exchange Server. For the Active Directory, following reports have been added:
  - a) **ESENT Database Performance report**
  - b) **Active Directory Web Services report**
  - c) **DFSR Replication Folder report**



#### d) **Replication Status**

For the Exchange Server following reports have been added:

- a) **SMTP Performance**
- b) **OWA Performance**
- c) **IMAP4 Performance**
- d) **ActiveSync Performance**
- e) **Information Store Performance**
- f) **POP3 Performance**

These reports are available in “Without Agent” auditing mode only.

- 5. In the latest version you can receive alerts and view reports in the palm of your hands. This has been made possible with the help of MobileApp which allows viewing reports and receiving important alerts on your mobile devices.
- 6. **Setting** page has been made more comprehensive which gives overview of all settings and the power to diagnose issues from a single location.
- 7. Process of running Logon/Logoff script (to generate logon/logoff report) has been simplified. Now users can run the script without specifying domain credentials.
- 8. Now all alerts in the system are created under one single tab: **Alert tab**. Here, you can create alerts for MobileApp, Livefeed, and Application. You can also create all these alerts on dashboard but it can be edited and managed only through Alert tab.
- 9. In the new version, users can define a **default SQL Server** to store audit logs and schedule archive. Therefore, at the time of running component adding wizard, you can simply select the default SQL Server and save the effort of specifying credentials.
- 10. A separate **Delivery Message Settings** page has been added so that you can do all the message delivery settings under one hood. On this page you can add Email accounts, Mobile App accounts, and do MobileApp data storage settings.
- 11. In the new version, archiving process has been made swift as you can create separate archive for all components.
- 12. The application's theme has been improved and the GUI of the latest version is visually more appealing.
