1 Introduction

The Lepide Solution allows you to set up a schedule to receive a daily summary of changes which have taken place on each of the components you have installed within the Lepide Data Security Platform. The summary is sent by email and appears in the inbox of the specified recipient at midnight each night. The email contains a separate PDF document for each component.

2 Enabling the Automatic Schedule Summary

To receive the automatic schedule summary, you first need to enable the option within the Settings screen. The steps to do this are as follows:

• Choose the **Settings** icon, then select **General Settings** from the tree on the left-hand side

The General Settings window will be displayed:

• Check the option Send Daily Change Report and click Apply

3 Specify the Email Recipient

The next step is to specify the email address of the person who should receive the report:

• Choose **Message Delivery Settings** from the tree on the left-hand side of the **Settings** screen. If the required email account does not exist in these settings, add the email account as follows:

From the Message Delivery Settings window:

- Click the Add 🖸 🔻 icon
- Choose Add Email Account:

4 Receiving the Change Summary Reports

• Once the report has run and the email has been generated, the user will receive an email in their inbox at midnight each night:
