### 3. FISMA Compliance Reports

These reports let your server components compliant with the rules of FISMA Compliance. Lepide Data Security Platform generates the following reports in this category.

Password History Policy Modified	This report shows all modified password history policies.
Logon Hour Expiration Policy Modified	This report shows all modifications made to the logon hour expiration policy.
